**ENTRIES:** Make checks payable to "Gavilan Chapter CDS". Shows #1 & 3 send entries to Laura Cobarruviaz, 10433 Duke Dr., Gilroy, CA 95020; Shows #2 & 4 send entries to Laurie Farmer, 200 Mission Vineyard Rd., San Juan Bautista, CA 95045. Entries may be limited to 2 rides per horse/rider combination. Show will close early if oversubscribed. **COPIES OF USEF AND CDS CARDS MUST BE MAILED WITH ENTRY OR ENTRY WILL BE CONSIDERED INCOMPLETE. MAIL ENTRIES ONLY; NO FAX OR HAND DELIVERY. INCOMPLETE ENTRIES WILL GO TO THE BOTTOM OF THE LIST. FREESTYLE: (USEF Rule Book, Art. 1928.9) A photocopy of the test verifying eligibility must be submitted with the entry for a freestyle class.**

**QUALIFYING:** "Q" after a class number and/or description refers to Great American Insurance/USDF Qualifying. If you intend to have the class count for Great American Insurance/USDF Qualifying, **add "Q"** to the class number and an additional **\$10** to the class fee on your entry blank. Please refer to page 139 in the 2008 Omnibus for the requirements. Eligible competitors must designate their entry as "Great American/USDF Qualifying" on the entry blank, and submit documentation to verify eligibility to enter the class.

**FEES:** Shows #1 & #3 CDS ONLY Training-Fourth Level \$40 / FEI \$45. Shows #2 & #4 USEF, USDF, CDS Training-FEI (classes 1-25) \$50 Quadrille, \$60/team. USDF Qualifying classes are the highest test of the level; please add a \$10 fee, (required by USDF) for each qualifying class you wish to enter. \$10 office fee/entry No refunds after closing date unless ride is filled. A \$10 fee will be deducted from refund. Post entries on a space available basis only. Any changes in an entry (classes, horse, rider, etc.) will be charged an office fee of \$10 per change. \$25 fee for all checks returned by the bank. Check website or Dressage Letters for Omnibus and Calendar updates. Entry forms at back of Omnibus.

**TIMES:** Posted on website. It is exhibitor's responsibility to contact Show Secretary if times are not received. Any class may be scheduled at any time. Competitors should be prepared to ride at any time. Special scheduling needs should be noted on entry.

**AWARDS:** Ribbons to fifth. Trophies in classes with 3 or more entries. Gavilan Series High Pt. award: Rider/Horse combination must ride highest test at both shows to qualify. Tri chapter challenge qualifying.

**STABLING:** **Limited stabling**, permanent with doors and covered paddocks. For fees and availability contact: Laurie Brunn in advance (831) 623-4112. Mail checks for stabling payable to "Osierlea" with entry.

**ACCOMMODATION/FOOD:** San Juan Inn (831) 623-4380; Mission Campground (831) 623-4456; Posada San Juan (831) 623-4030. Breakfast and lunch available at show.

**DIRECTIONS:** Highway 101 to Highway 156 in San Juan Bautista. East to traffic light, right on Alameda, hard left on Mission Vineyard (follow sign toward St. Francis Retreat) - 334 Mission Vineyard, 3/10 mile on left.

**FOOTING & OTHER:** Warm-up area is indoor sand; competition court (20x60m) is outdoor sand. Dogs not allowed on show grounds! On call veterinarian and farrier - information will be posted in show office. Protective headgear must be worn while mounted.
